INVOICING INSTRUCTIONS

Evaluated Receipts Settlement (ERS)

Evaluated Receipts Settlement (ERS) is an option active for North America region for suppliers who submit a large number of invoices.

Aptiv encourages high volume suppliers to interact with Aptiv using an ERS.

Benefits to the Supplier include:

- Cashflow benefits
 - Invoices always paid on time
 - Invoices are still paid when discrepancies occur
- Increased transparency to payments
 - Payments are scheduled and confirmed upon receipt of goods
 - Discrepancies are immediately communicated upon receipt of goods giving advanced notice to be able to resolve before payment
- Reduced costs
 - Eliminates delivery costs
 - Reduces invoicing / payment issues

PDF invoices

This is Aptiv's preferred method for receiving invoices from Suppliers who submit medium to low volumes of invoices. Suppliers are encouraged to use this method because of the many benefits to both Aptiv and Supplier.

- Immediate transmission of invoices
- Reduced occurrence of lost invoices
- Lower transaction costs

Email PDF invoices directly to Aptiv using the email address listed in the contacts section of this document. When emailing please ensure that:

- Include only one invoice per PDF
- Include only one PDF per email
- File size must be less than 4Mb
- Note: email content will not be read so please do not include any email content

To begin sending PDF invoices, find the appropriate email address in the contact section. For most countries you can start sending your PDF invoices immediately.

Paper invoices

Suppliers are discouraged from using paper invoices and encouraged to use PDFs where possible because of the many benefits to both Supplier and Aptiv.

Invoices submitted as hard-copy documents sent via mail, post, courier etc. MUST be sent to the correct address.

Billing addresses are provided on every Purchase Order Document and a full listing is provided in this document under the contact section.

Once registered on the Aptiv Supplier Portal, Suppliers will, where appropriate and jointly agreed, have the opportunity to access to the various applications hosted on the portal and view their transaction details (deliveries, receipts, payment statuses, etc). Your invoice transactions and invoice statuses can be found under the eAptivPay section of the Aptiv Supplier portal.

Accounts payable helpdesk

Aptiv's accounts payable helpdesks assist with invoice and payment queries that cannot be resolved by the portals. Helpdesks can be contacted by email. Contact details are listed in the contacts section of this document.

Suppliers should raise issues to the appropriate Aptiv team to ensure effective & timely resolution of queries.

Invoice & payment status: Contact **AP Helpdesk**. North American Suppliers log onto eAptivPay or ePayment portals.

Payment remittance information: Contact **AP Helpdesk** if you need your payment remittances emailed to a different address.

Quantity discrepancy: Contact **point-of-receipt** at the receiving site.

Missing shipment on eAptivPay: Contact site **point-of-receipt** if no RECADV is received or shipment is not appearing on eAptivPay.

Price discrepancy: Contact **purchasing buyer**.

INVOICE REQUIREMENTS

In all cases the following requirements apply to PDF & hard copy invoices. Failure to comply with these requirements may result in payment delays and/or return of invoices to Suppliers.

1. Vendor Legal Name.
2. Vendor's Registered Address.
3. Vendor's Tax Identification Number.
4. Vendor's invoice number. It is preferred that this number does not contain any special characters such as -, /, _, etc.
5. Invoice date. Accurate invoice date and within 5 days of invoice submission date.
6. Correct Aptiv customer (Bill-To) name and Aptiv GST/VAT/Tax Identification number.
 - (a) Aptiv requires Purchase Orders / Schedule Agreements for all goods and services. Aptiv Purchase Orders are available as PDF documents. If you do not receive this, please request one from the person placing the order.
8. Delivery Note number on invoices for goods. Delivery number must exactly match the delivery number on your ASN (Advance Shipping Notification)
9. Description of the goods or services. Where possible, the same description as on the Purchase Order should be used.
10. Quantity of the goods or services. This should match the delivered quantity.
11. Unit of measurement. In the same units as the Purchase Order.
12. Unit price. In the same currency as the Purchase Order.
13. Total amount excluding tax. In the same currency as the Purchase Order.



14. Tax amount. In the same currency as the Purchase Order.

15. Total amount including tax. In the same currency as the Purchase Order.

16. Shipment number. For freight and custom charges.

17. Delivery address. The address to which goods are delivered or at which services are provided. Note

(a) Invoices should not include additional charges that are not on the Purchase Order. If there are additional charges, please agree a billing procedure with the Aptiv contact, request an additional Purchase Order and invoice separately.

(b) Only invoices will be paid. Statements, delivery tickets, pro-forma invoices or other documents will not be processed for payment without prior approval from Aptiv.

(c) In certain countries, supplier invoices may be required to include additional information. Suppliers are expected to understand and follow applicable invoice format requirements.

INVOICE DISPUTES

Any dispute in price or quantity must be supported by credit note. The invoice will remain unpaid until the dispute is resolved.

Credit notes should quote a reason for the credit, the original invoice number, Purchase Order number, Return Order (RMA form number for goods return) that they refer to.

Any credit note that does not quote these numbers may be deducted from your next payment and the invoice it relates to may remain unpaid.

Remittance Advice Notes

Remittance Advice Notes are sent directly from Aptiv's ERP system (SAP) in the moment of finalizing the process in the SAP system and forwarding payment instruction to Aptiv's bank, and have the following form:

- Remittance Advice Notes are sent from the generic mailbox: Payment.Advice@Aptiv.com
- The subject of the email is standard: 'Payment Advice from Aptiv'
- The e-mail is supplied with a PDF document which contains Payment Details such as: the booking number in Aptiv's system, the number of supplier's document, the date of supplier's document and the amount paid by Aptiv
- Communication is maintained in English

Since Remittance Advice Notes are sent from the generic mailbox Payment.Advice@Aptiv.com it may happen that they end up in the Spam box. In such case, the supplier must mark the address as trusted, so that the next time Remittance Advice Notes are delivered correctly to the main mailbox.

Please note that Payment.Advice@Aptiv.com mailbox is not intended to receive/respond; our Help Desk emails remains unchanged for any further question you would have.

Suppliers can contact Aptiv's AP Helpdesk team to confirm and update email addresses to be used when Remittance Advice Notes are sent.
